Process to prioritise sites for review using the Rural and Remote Maternity Services Planning Framework

The purpose of this process is to assist Hospital and Health Services in the prioritisation of rural and remote maternity services within their catchments for review.

Process

HHS identify sites that have a Modified Monash Model (MMM) rurality rating of 3 or higher (appendix 1) and meet at least one of the criteria in Table 1.

If there are multiple sites that meet criteria in table 1, the criteria in table 2 and contextual information in table 3 can be used to assist in prioritising the sites for review.

HHSs should review their services as a network i.e. no facility should be reviewed in isolation.

HHS stakeholders should be involved in this process, and can include but are not limited to Executives, service planners, maternity service directors (midwifery and obstetrics), representation from First Nations Health service providers, consumers, and GPs.

Development of the prioritisation process and criteria

In developing the process and criteria to prioritise maternity sites for review using the Rural and Remote Maternity Services Planning Framework the following factors were taking into consideration:

- The variability between communities due to a multitude of factors including (but not limited to) geography, demographics, cultural, socioeconomic status.
- The criteria and process should complement the Growing Deadly Families Strategy
- Weighting is used to assist in informing the prioritisation process.
 - Absolute numbers are not provided for the majority of the weighted criteria because the prioritisation is based on comparison of the sites within the HHS.
- It is intended that the criteria are viewed collectively to give a 'picture' of the sites in the HHS and not as stand-alone definitive criteria
- Criteria can be applied across all facilities (not just birthing services) e.g. ability to provide
 caesarean on-site should not be used as a criterion as it only applies to those birthing services
 as specified within the CSCF.

As noted in the Rural Maternity Taskforce Report, the data that can be analysed tells only a part of the story and requires context that is provided by the stakeholders in the rural and remote communities, and the HHSs that provide the services to those communities.

There is no 'one size fits all' process or criteria for determining which services should be reviewed. The prioritisation process has been developed to enable it to be situation specific and based on the collective needs of community and stakeholders.

Criteria that were suggested but are not included (and the reasons why they are not included) are:

- PROMS and PREMS not currently being undertaken in Maternity. If/when they are introduced, they could be included in the data HHSs use when reviewing services.
- Perineal bundle / Perineal Care Guideline use only applicable to birthing services. Whether it is implemented or not is not directly related to rurality of service.
